

**USE OF TECHNOLOGY AGREEMENT:  
STUDENT/PARENT ACKNOWLEDGMENT**

**STUDENTS:** I have read and will abide by the Technology Use Policy (hereafter referenced as the “TUP”) of Saint Demetrios Preparatory. I further understand that any violation of that agreement is unethical and may constitute a criminal offense. Should I commit any violation, my access privileges may be revoked and school disciplinary action, as set forth in the School’s Code of Conduct, and/or appropriate legal actions may be taken.

**PARENTS/GUARDIANS:** I have read and agree to assist my child in understanding and abiding by the TUP of Saint Demetrios Preparatory. I understand that access to Technology, as defined in the TUP, (“Technology”) is designed for educational purposes. I also recognize that some materials on the Internet may be controversial and objectionable and that, while every attempt will be made to block inappropriate sites accessible through the School’s network, it is impossible for the School to restrict access to all controversial and objectionable materials. I also understand that the School may provide students with hardware or devices that are capable of accessing Internet sites off school premises that do not themselves filter access to Internet sites. I will not hold Saint Demetrios Preparatory School responsible for the accuracy or quality of any materials acquired via or viewed on Technology by my child. I understand that improper or inappropriate use of Technology by my child may result in revocation of his/her Technology privileges and the imposition of school discipline, criminal penalties, or civil penalties. I accept all financial and legal liabilities that may result from my child’s misuse of Saint Demetrios Preparatory School Technology. I release the Saint Demetrios Preparatory School, its officers, employees, agents, representatives, and all organizations and individuals related to the Saint Demetrios Preparatory School’s Technology from any and all liability or damages that may result from my child’s misuse of the School’s Technology. I specifically agree to indemnify and hold the Saint Demetrios Preparatory School, its officers, employees, agents, and representatives harmless from any actions, claims, costs, damages, or losses, including, but not limited to, attorney’s fees, incurred by the Saint Demetrios Preparatory School relating to, or arising out of my child’s misuse of Technology.

**MOBILE DEVICE USE:** If your child will be issued school equipment in support of his/her education in Saint Demetrios Preparatory. The device and its content remain the property of Saint Demetrios Preparatory. The School’s TUP fully applies to the use of this equipment both on and off school premises. The device’s settings have been adjusted for appropriate school use. These settings must not be altered, deleted or circumvented in any way. The also has downloaded applications to the device for student use. No additional applications may be added to the device, whether for purchase or free, other than by authorized personnel. The student and parent/guardian agree to be responsible for the maintenance and care of the device, and to return it when requested in the same condition in which it was received, except for normal and reasonable wear and tear. The parent/guardian will be responsible for excess wear and tear. Use of the device is not private and the device may be inspected periodically to check for appropriate use and compliance with policies.
